# YOGYAKARTA TRANSIT TOUR (ONE DAY TOUR)

The tour will begin with an early morning transfer to the airport for a flight to Yogyakarta. Upon arrival, you will be greeted at the airport and taken to the world famous Borobudur Buddhist Temple which was built in the 8th century. You will also be able to see more than 500 Buddha statues and will visit the nearby smaller Mendut Temple. Returning to Yogyakarta, you will have the opportunity to visit the Sultan's Royal Palace (Keraton), Batik and Leather (Shadow Play), puppet home shops, and Kotagede silversmiths. Lunch at a local restaurant is included. The day will end by flying back to Jakarta, where you will then be transferred to your hotel.

There is a minimum of two persons for this tour, with the price being US \$175. This price will include air conditioned travel, an English speaking guide, lunch enroute, transfers in and out of Jakarta, parking and entrance fees, donation, toll fees, and tips. The price excludes travel insurance, airfares and airport taxes, and all personal expenses.
